3 - Do formato

- 3.1 O formato dos campeonatos e suas categorias, são de critério da organização, podendo ser mantidas o formato original.
- 4 Do tempo para realização do evento
- 4.1 Serão permitidos eventos com no máximo 6 dias, conforme sua modalidade.
- 4.1.1 Para Copa de Marcha, deverá ser 01 (um) dia para admissão dos animais e 03 (três) dias de Provas;
- 4.1.2 Para Exposições, deverá ser 02 (dois) dias para admissão dos animais e 04 (quatro) dias de Provas e Julgamentos;
- 4.1.3 Para Enduro Equestre Velocidade Livre, deverá ser 02 (dois) dias para admissão dos animais e 02 (dois) dias de provas;

- 4.1.4 Para Mangalargada ou Enduro Equestre Velocidade Controlada, deverá ser 01 (um) dia para admissão dos animais e 01 (um) dia de provas
- 4.2 A organização deverá manter rigorosamente os horários estipulados para cada categoria;
- 4.3 Todas as pessoas, incluindo motoristas, treinadores, prestadores de serviço, organização e veterinários, deverão permanecer de máscara durante todo o período do evento;
 - 4.4 A organização disponibilizará Álcool em gel em todo o recinto.

5 - Do público externo

- 5.1 Os eventos serão fechados para o público externo;
- 5.2 Cada animal poderá contar com apenas 01 (uma) pessoa, sendo ela apresentador, treinador ou proprietário.

6 - Do grupo de risco

- 6.1 É recomendado que pessoas acima dos 60 anos, não participem ou se dirijam ao evento;
- 6.1.1 Essa recomendação estende-se a todos, motoristas, apresentadores, treinadores, proprietários, organização e equipe de apoio.
- 6.2 Pessoas que pertencem ao grupo de risco que precisarem adentrar ao local do evento, deverão se identificar e assinar um termo de responsabilidade.

7 - Da recepção dos animais

- 7.1 Além das regras para recepção de animais conforme o Decreto Estadual Nº 45.781, de 27 de abril de 2001, devem ser adotados novos procedimentos para conter o avanço e a disseminação do vírus da COVID-19 durante os eventos Pecuários Esportivos (concentração animal).
- 7.2 O ambiente de inspeção deverá estar devidamente limpo e deverá ser higienizado a cada 02 (duas) horas;

- 7.3 Todos os veículos devem ser pulverizados na entrada do recinto com solução desinfetante, conforme já previsto Decreto Estadual № 45.781, de 27 de abril de 2001;
- 7.4 Os profissionais responsáveis pela recepção dos animais deverão respeitar o distanciamento social;
 - 7.5 Todos profissionais deverão obrigatoriamente usar EPIs;
- 7.6 A recepção contará com um responsável para a fiscalização e aferição de temperatura de todos os profissionais que acompanham os animais (motorista, tratador, treinador ou proprietário);
- 7.7 A organização deverá disponibilizar na recepção, Álcool em Gel 70% para uso coletivo;
- 7.8 O estacionamento dos caminhões e Trailers deverá ser pré marcado com espaçamento entre os mesmos;
- 7.9 A organização manterá o controle do espaço destinado ao estacionamento dos caminhões e trailers, ficando expressamente proibida confraternização em qualquer espaço da prova;

8 - Da secretaria

- 8.1 A secretaria deverá conter no máximo 02 (dois) atendentes;
- 8.2 O atendimento da secretaria será restrito a dúvidas e informações;
- 8.3 Toda inscrição deverá ser feita com no máximo 02 (dois) dias de antecedência do início do evento;
- 8.4 Todos os pagamentos, como, inscrições, baias e GTAs deverão ser feitos on line antes do início do evento;
 - 8.5 Os atendentes deverão usar EPIs;
 - 8.6 A organização deverá disponibilizar álcool em gel 70% para uso coletivo;
- 8.7 A premiação ocorrera nos moldes normais, só não será possível a presença da equipe junto aos animais na premiação;
 - 8.8 A organização deverá disponibilizar os resultados de cada prova on line;

8.9 - Não será permitida a permanência no recinto após as competições, ao termino do evento, todos devem se retirar.

9 - Da área comum

- 9.1 A organização deverá disponibilizar álcool em gel 70% em toda área comum;
- 9.2 A organização deverá manter uma pessoa responsável pela limpeza e higienização da área comum durante todo o evento, e isso a cada 2 horas.

10 - Do padock

- 10.1 Só serão permitidos no padock 01 (uma) pessoa da organização para distribuição de camisetas numeradas e o técnico responsável pela admissão dos animais na pista;
 - 10.2 Todos no padock deverão estar usando EPIs;
- 10.3 O padock somente será liberado para os competidores da categoria anunciada pela organização.

11 - Das obrigações

- 11.1 É obrigação de todos seguir as regras e boa conduta, preservando a vida e para conter o avanço e a disseminação do vírus durante os eventos;
- 11.2 É de responsabilidade da organização o monitoramento da temperatura de todos na entrada do evento e quando solicitado;
- 11.3 É de responsabilidade da organização manter a disponibilidade de álcool em gel 70% e papel toalha em vários pontos do evento para uso coletivo;
- 11.4 Exibir cartazes e informativos sobre a higienização e conduta adequada;
- 11.5 Falar no sistema de som sobre a COVID-19 e suas formas de prevenção, tanto durante as categorias como em seus intervalos;
- 11.6 Manter cadastro e monitoramento atualizado dos participantes, durante e após o evento para feedback e possíveis pesquisa;

11.7 - É dever de todos participantes a comunicação imediata a organização do evento, caso venha a apresentar algum sintoma, durante ou após o evento (período de 15 dias).

12 - Da responsabilidade

- 12.1 É de responsabilidade da organização a divulgação desse livro de regras;
- 12.2 Para segurança de todos a organização deverá disponibilizar sistema on line para inscrição, reserva de baias e pagamentos;
- 12.3 Fica a critério da organização em contratar uma empresa para transmissão do evento ao vivo em tempo real, assim proprietários e simpatizantes da raça poderão acompanhar todo evento sem a necessidade de se deslocarem ao recinto;
- 13 É de inteira responsabilidade da organização, seguir e fazer cumprir esse livro de regras, zelar pela saúde de todos os profissionais envolvidos no evento.

IV. THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

- 1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
- 2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
- 3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
- 4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
- 5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

NB: for Horses permanently resident in a Member State of the European Union: all Horses must have a national EU passport in compliance with EU Regulations to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

All FEI registered Horses intending to compete at FEI Events (including CIMs) must be vaccinated against Equine Influenza in accordance with these VRs. The exception being if the applicable domestic legislation prevents the use of Equine Influenza vaccines within the



relevant territory.

6.3 Examination On ArrivalFEI Veterinary Regulations Article 1031

On arrival at an Event venue all Horses must undergo an examination by a veterinarian to confirm their identification from their passport and micro-chip ID (where present), their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status, concerning vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue.

6.4 Horse Inspections

FEI Veterinary Regulations Articles 1034-1042

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit to compete by the Inspection Panel will not be permitted to compete.

6.5 Limb Sensitivity ExaminationFEI Veterinary Regulations Articles 1048-1053

All Horses are subject to examination under the protocol for abnormal limb sensitivity throughout the period of an Event. For Jumping that includes, but is not limited to, between rounds and before the Jump Off. For Endurance that includes, but is not limited to, pre-ride, during the ride and after the ride. Horses may be examined once or on multiple occasions during the Period of an Event.

Horses may be selected for examination under the protocol randomly or they may be targeted. All Horses selected to be tested must submit promptly to the examination or are subject to immediate disqualification. There is no obligation to examine any specific number of Horses at an Event.

7 Equine Anti-Doping And Controlled Medication Programme (EADCMP).

FEI Veterinary Regulations, Chapter VII

7.1Sampling.

FEI Veterinary Regulations, Chapter VII

All horses competing at FEI Events may be subject to sampling for the presence of FEI Equine Prohibited Substances in accordance with the FEI Equine Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. Refer to FEI Financial Charges for details of fees relating to Equine and Human Anti-Doping program (EADCMP), which OCs/NFs have the right to charge to the athlete (applicable for all FEI events worldwide).

7.2 Elective Testing.

Elective Testing may be carried out prior to an Event to check for the presence of Prohibited Substances. Please refer to http://inside.fei.org/fei/your-role/veterinarians for information and details.



7.3 Hyposensitivity Control System Examination FEI Veterinary Regulations, Annex VIII

All horses competing in FEI Endurance events are subject to Hyposensitivity Control System Examination. Horses may be examined once or on multiple occasions during the Period of the Event and may be selected randomly and/or target tested by the Ground Jury and/or Veterinary Commission

All horses selected to be tested must submit promptly to the examination. A refusal by the PR or his/her representative to submit a horse for examination will lead to disqualification and a yellow warning card. Withdrawal of the horse is not allowed once the PR or support personnel has been notified that the examination is to take place.

XIV. HUMAN ANTI-DOPING

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. Organisers will have the responsibility to provide facilities and staff/volunteers to facilitate such Testing if requested by the FEI as outlined in article 22.3 of the FEIs' Anti-doping Rules for Human Athletes (ADRHA).

1. THE FEI POLICY FOR ENHANCED COMPETITION SAFETY DURING THE COVID-19 PANDEMIC

The FEI Policy for Enhanced Competition Safety during the Covid-19 Pandemic ("Policy") https://inside.fei.org/fei/covid-19/return-to-play/policy-tools is mandatory and applies for any FEI Event taking place as of 1 July 2020. Events for which the FEI has not received the documented risk assessment and mitigation measures plan in accordance with article 2.1.g) of the Policy **will be removed from the FEI calendar** in accordance with Article 112.3 of the FEI General Regulations.

ASSUMPTION OF RISK / WAIVER OF LIABILITY

In consideration of being allowed to participate in the Event and related activities, all Participants (as defined in the Policy) acknowledge, appreciate, and agree that:

- Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
- 2. The Participants knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the OC or others, and assume full responsibility for their participation; and,
- 3. The Participants willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, a Participant observes any unusual or significant hazard during his/her presence or participation, the Participant will remove himself/herself from participation and bring such to the attention of the nearest official immediately; and,
- 4. The Participants, for themselves and on behalf of their heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE OC AND THE FEI, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

The Participants confirm to have read this release of liability and assumption of risk agreement, fully understand its terms, understand that they have given up substantial rights.



2. Insurances And National Requirements

In exceptional circumstances, together with the approval of Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the Organiser may change the schedule in order to clarify any matter arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the Technical Delegate.

2.1 ATHLETES, OWNERS AND SUPPORT PERSONNEL

2.1.1 Personal Accident and Health Insurance

It is your responsibility as an Athlete/Owner/ Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at FEI Events and in particular to insure against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a FEI Event.

You should check with your National Federation to confirm if your National Federation's insurance policy (if any) covers personal accidents and/or illnesses which may occur when you are attending at/participating in FEI Events.

If your National Federation does not have a personal accident/health insurance policy or if the National Federation's insurance policy does not cover personal accident or health claims, then you should obtain your own personal accident and health insurance policy to cover your attendance/participation at FEI Events.

2.1.2 Personal Property Insurance

You should also ensure that you are insured against property loss, theft or damage which may occur at an FEI Event.

Again, the advice is to check with your National Federation to confirm if they have an insurance policy in place which would cover you in case of such property loss, theft or damage. If not, then you should obtain your own personal property insurance to cover such situations.

2.1.3 Press Equipment

Press equipment and other items left in the Press workroom, Press lockers, the Press Tribune or anywhere on the showgrounds are left entirely at the owner's risk. The Organising Committee does not accept any responsibility for any loss or damage to such equipment or items. Members of the Press are advised not to leave any equipment or personal items unattended.



2.2 ATHLETES AND OWNERS

2.2.1 Third Party Liability Insurance

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation to FEI Events at home and abroad, and to keep the policy up to date.

The FEI and the Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

2.2.2 Additional Liability Information

As an Owner you should ensure that your Horses are adequately insured against any injuries or illnesses they may sustain while participating at a FEI Event.

<u>FEI Permitted Treating Veterinarians (PTVs) (Art 1005) are to have adequate professional indemnity insurance.</u>

3. Protests / Appeals

To be valid, all Prostests and Appeals must be made in writing and accompagnied by a deposit of CHF150. – or equivalent.

4. Disputes

In the event of any discussion concerning the interpretation of the schedule (in translated languages), the English version will be decisive.

5. Modifications Of Schedule

In exceptional circumstances, together with the approval of Chefs d'Equipe and Ground Jury the OC reserves the right to modify the schedule in order to clarify any matter or matters arising from an omission or due to unforeseen circumstances.

Unforeseen circumstances do not include situations arising as a results of the OC altering the approved Schedule without FEI's authorisation. Any such changes must be notified to all competitors and officials as soon as possible and they must be reported to the FEI Secretary General by the Foreign Judge.

Please note that as per Art. 109.6 (GR): ORGANISERS of International Events must inform the FEI and NFs whose teams or individuals have taken part, of the results and prize money paid to each placed Athlete and team, within five (5) days following the Event, unless otherwise specified for qualification and ranking reasons as communicated by the FEI.

Failure from ORGANISERs of International Events to provide the FEI with the appropriate result(s) and/or prize money information by the aforesaid deadline and/or in the aforesaid format shall entail a warning for the first violation and thereafter a fine of CHF 1'000.- per violation.

The FEI may request a copy of the official PDF result signed by the relevant Officials at the Event.



FEI Endurance Organisers' Protocol

With an aim to further ensure the welfare of equine and human athletes at International Endurance Events, the safety of all participants and the implementation and respect of common principles of behaviour, fairness, and sportsmanship, the FEI has created this FEI Endurance Organiser's Protocol (hereinafter the "Endurance Protocol") to guarantee the correct and full application of the applicable FEI Rules and Regulations in your Events, in particular but not limited to, the FEI General Regulations, the FEI Endurance Rules, the FEI Veterinary Regulations, the FEI Anti-Doping Rules for Human Athletes and the FEI Equine Anti-Doping and Controlled Medication Regulations.

In order for the FEI to approve the competition schedules the Endurance Protocol **must** be signed by the Organiser and the National Federation, listing the Event(s). By signing the Endurance Protocol both aforementioned parties agree to comply with all applicable FEI Rules and Regulations, and in particular (but not limited to), with the following requirements:

- 1. Full cooperation must be given to the FEI Officials to ensure that they can perform their tasks according to the FEI Endurance Rules, in particular:
 - Ground Jury Art. Art. 853
 - Technical Delegate Art. 852
 - Veterinary Commission Art. 854
 - Chief Steward Art. Art. 855
- 2. Full cooperation must be given to the FEI Independent Governance Advisors (IGAs) to ensure that they can perform their tasks according to the FEI Endurance Rules Art. 856
- 3. The welfare of the horse must be a first priority and you must allow the FEI Officials to take all necessary measures to safeguard it, as per the FEI Endurance Rules, including but not limited to:
 - Loops of the course must not be specially designed and/or constructed to encourage high speeds Art. 818
 - Allowing for the reduction of the pulse criteria Art. 816.9.2. The pulse criteria may be reduced during the ride if, in the opinion of the President of the Veterinary Commission in consultation with the Foreign Veterinary Delegate, the President of the Ground Jury and the Technical Delegate they believe there is a danger to the safety of the Horses.
 - The Veterinary Commission has absolute control on all matters concerning horse welfare Annex 5, Art.1.
 - The Technical Delegate or the Ground Jury together with the Veterinary Commission can decide to modify the length of timed holds according to extreme weather conditions or other exceptional circumstances.... Art. 816.9.3.



- 4. The safety of the athletes, FEI Officials and public must be safeguarded at all times and FEI Officials must be allowed to take all necessary measures to ensure safety, as per the FEI Endurance Rules/FEI GRs:
 - The field of play Art. 813
 - Number of crew members allowed Art. 813.2.2
 - Horses must remain capable of being clearly observed at all times Art. 813.5
 - Permitted Assistance during Event or on Course Art. 822.4
 - Prohibited Assistance Art. 822.5
 - Postponement and/or cancellation of an Event FEI GRs 109.12
- 5. The FEI Officials' Code of Conduct must be adhered to including the obligations and restrictions pertaining to the "Endurance Official's Per Diems".

Any breach of the FEI Rules and Regulations will be prosecuted according to the FEI Legal System (Chapter VIII of the FEI General Regulations).
